It features a locking latch mechanism and includes all of the fasteners required for installation. The dock barrier is held together by heavy duty plate steel hinges that contain 1" pivot pins with oilite bronze self-oiling bushings.

OSHA has new requirements for loading docks, indoor docks, and any other in-plant areas that have unprotected sides or edges that are 4 feet or higher. These new requirements are designed to keep people safe and to prevent loading dock accidents. BG Dock Defender Barriers help meet OSHA compliance.

- 1910.28(b)(1)** Unprotected sides and edges - Except as provided elsewhere in this section, the employer must ensure that each employee on a walking-working surface with an unprotected side or edge that is 4 feet (1.2 m) or more above a lower level is protected from falling by one or more of the following:
- 1910.28(b)(1)(i)(A)** Guardrail systems;
 - 1910.28(b)(1)(i)(B)** Safety net systems; or
 - 1910.28(b)(1)(i)(C)** Personal fall protection systems, such as personal fall arrest, travel restraint, or positioning systems.
